## **PAYMENT CONDITIONS**

If you want to make a reservation you must pay 50% of the total price ten days before boarding. If you have not paid this amount your request will be canceled. The other 50% must be paid before boarding.

## CANCELLATION POLICY

If ALINA SAILING cancels the contract, all paid money will be refunded to the customer. In the case of bad weather conditions (Captain Decision), the contract will be canceled. First of all, we will try to change the day of the chartering if possible both for us and for the customer. If it is not possible all paid money will be refunded to the customer.

If the customer cancels the contract five days before boarding he will lose the money paid for the reservation.

Sailboat maximum capacity is 12 people including crew.

## **CHARTER TERMS & CONDITIONS**

**OBJECT OF THE CONTRACT:** The lessor is the owner of the sailboat which is the object of this contract, model BENETEAU OCEANIS 50, registration 6<sup>a</sup> PM-9-1-14, whose name is 'ALINA' being the maximum number of persons allowed to board of 12 people.

**SKIPPER:** Sailboat is rented with crew. The crew is composed by his professional skipper M. IGNACIO MORROS, Identity Card Number: 02652617-G. The professional Spanish title of the skipper is 'PATRÓN PROFESIONAL DE EMBARCACIONES DE RECREO', Number of Registry: 1696.

Customers are required to follow the instructions of the Skipper.

The skipper may decide to terminate the trip if a customer's behavior endangers the safety of navigation, of persons on board or the sailboat itself.

**TERM OF THE CONTRACT:** Delivery of the sailboat which is the object of this contract will be made on (Day) at (Time) in IBIZA and her return will be on (Day) at (Time) in IBIZA, .

Upon her return customers and their baggage must be unloaded, leaving the sailboat ready for review by the lessor. Subsequently both parties will sign the review document up indicating their compliance or the defects that may exist.

**PRICE:** The rental price of the sailboat is  $(Price) \in (VAT \text{ included}).$ 

The price includes a policy of liability insurance and an accident insurance policy for all passengers on board.

The price includes professional skipper.

Price does not include: provisioning expenses, food, mooring buoys, fuel and bedding.

Only cash or a bank transfer will be accepted for the payments described in the general and specific terms of this contract.

**CONSERVATION:** The customer agrees to preserve the sailboat in accordance with good seaman practice and he will do everything possible to avoid losses, accidents or breakdowns.

**INSURANCE:** The sailboat has a policy of liability insurance and an accident insurance policy for all passengers on board.

**SECURITY DEPOSIT:** If it has been agreed to receive a security deposit by the customer before boarding, this would serve to cover any damage, loss or theft of any object not covered by the Insurance Company. However, if the resulting amount for damages is higher than the security deposit amount, the customer must pay the difference. The deposit will be returned to the customer after checking the condition of the sailboat and after having done the inventory and repair if it is necessary.

**TERMINATION OF THE CONTRACT:** If the contract is resolved because the customer, he would lose the money previously paid and he would be obliged to pay to the lessor the outstanding amount of entering. The lessor may terminate the contract in the event that causes beyond his control could not make available to the customer the sailboat hired on the date that should proceed to the delivery thereof. In that case, all paid money will be refunded to the customer. In no case the customer may require to the lessor any compensation for the unavailability of the sailboat which is the object of this contract.

**JURISDICTION:** The parties agree to submit to the courts of Alicante to resolve any dispute arising as a result of this agreement.

## TIPS:

- -Please, to not throw into the toilet paper, cottons or compresses. It could clog the WC.
- -Please, to not waste the freshwater. Water is limited to the capacity of the sailboat's tanks.
- I will always use bottled water for drinking and cooking.
- I will not waste electricity on board
- -Please, to not leave the sailboat without people on board

-Food on board: welcome aperitif is included. If you are going to be on board several days: make the purchase before leaving. If you provide us the shopping list we can make the purchase for you.

Best food on board: pasta, cold cuts, salads and snacks...

Avoid perishables (meat, summer's fruits) and voluminous fruits (water melon...)

Avoid glass bottles. Buy mineral water in bottles of 1,5 L. Other beverages in cans.

Calculate a liter and half of water per person per day.

Do not forget toilet paper and paper towels, detergent for dishes and scourer.

If you do not want to wash the dishes, buy paper cups and paper dishes.

- -Clothing on board: white sole shoes for walking on deck and shower sandals, warm clothing for night sailings and windbreaker raincoat. Cover your head with a hat for the day and wool cap for the night. Sunglasses. Sunscreen.
- -You must be ordered on board
- -Avoid getting wet inside the sailboat
- -In the Kitchen: Do not cook with swimsuit. You could burn your body and your legs. Please, to not leave the fire unattended. If you are boiling liquids, use high pans.
- -Take care with your mobile phone and electronic devices.
- -Please, to maintain clear deck when we get into port.
